1. Ordnance 2018-17 ordinance 2018-17 an ordinance amending the provisions of chapter 8 (business licenses) article iv (alcoholic liquor sales, division 2 (licenses) paragraph 8-120 schedule B ("number of licenses)" pertaining to alcoholic liquor sales of the Indian Head Park municipal code

Trustee Mann made a motion pass ordinance 2018-17 an ordinance amending the provisions of chapter 8 (business licenses) article iv (alcoholic liquor sales, division 2 (licenses) paragraph 8-120 schedule B ("number of licenses)" pertaining to alcoholic liquor sales of the Indian Head Park municipal code

Motion seconded by Trustee Conboy

Administrator DuRocher explained the ordinance. He stated that this was at the Village's sole discretion

Trustee Farrell-Mayer expressed concern as to the number and amount of liquor licenses and gaming licenses at the shopping center.

Motion carried by roll call vote (4-1). Trustees Metz, Wittenberg, O'Laughlin, Mann and Conboy voted yes. Trustee Farrell-Mayer voted Nay. Trustee O'Laughlin absent.

2. Ordinance 2018-18 an ordinance amending the provisions of chapter 8 (business Licenses) division 2 (video gaming); paragraph 274 (number of Licenses) of the code of Indian head park to increase the maximum Number of video gaming location licenses and the maximum number Of video gaming terminal licenses (RDSGA, LLC, d/b/a Facetime Social)

Trustee Metz made a motion pass ordinance 2018-18 an ordinance amending the provisions of chapter 8 (business Licenses) division 2 (video gaming); paragraph 274 (number of Licenses) of the code of Indian head park to increase the maximum Number of video gaming location licenses and the maximum number Of video gaming terminal licenses (RDSGA, LLC, d/b/a Facetime Social)

Motion was seconded by Trustee Mann

Administrator DuRocher explained the ordinance. He stated that this was at the Board's discretion. He stated that the Village sets the number. He stated that the applicant needs to apply to the State of Illinois, but that he has not done so. He gave a report as to his analysis of gaming revenue to date.

Trustee Metz stated that he felt it was a market issue. Trustee Farrell-Mayer restated her position.

Motion carried by roll call vote (4-1). Trustees Metz, Wittenberg, O'Laughlin, Mann and Conboy voted yes. Trustee Farrell-Mayer voted Nay. Trustee O'Laughlin absent.

3. Motion to remove Ordinance 2018-15 from the table

4. Motion to pass Ordinance 2018-15 An Ordinance Allowing for the Sale of Surplus Property (Two International Trucks)

Trustee Mann made a motion to pass Ordinance 2018-15 An Ordinance Allowing for the Sale of Surplus Property (Two International Truck.

Motion seconded by Trustee Metz.

Administrator DuRocher explained the process for selling the two proposed vehicles and the rationale behind his request. He stated that when the Village purchased the 2016 International that we were supposed to sell the 1996 International but the Village had not done so as of yet.

Administrator DuRocher stated that there is not a lot of data available as to determining the value. Both at he set the minimum sale price fairly high to "make it worth our while" He will target the October municipal auction.

Trustee Mann stated that there was utility to the Village in keeping the newer of the vehicles and that he was not in favor of selling the 2016

DuRocher stated that the Village has budgeted a new F-350 and is proceeding with its purchase through State bid.

Motion carried by roll call vote (4-1). Trustees Farrell-Mayer, Metz, Wittenberg, and Conboy voted yes. Trustee Mann voted Nay. Trustee O'Laughlin absent.

5. Motion to approve the settlement of the Kielczynski lawsuit. Ordinance 2018-19

Trustee Metz made a motion to approve Ordinance 2018-19 an ordinance authorizing the execution of a settlement agreement involving Lyons Township ex. rel. John H. Kielczynski vs. Village of Indian Head Park.

Motion seconded by Trustee Mann.

Motion carried by roll call vote (5-0). Trustees Mann, Farrell-Mayer, Metz, Wittenberg, and Conboy voted yes. No Nay votes. Trustee O'Laughlin absent.

6. Motion to pass Ordinance 2018-20 Illinois American Water Contract extension for Six Months (Trustee Mann)

Trustee Mann made a motion to pass Ordinance 2018-20 An Ordinance extending the Water Operations Contract with Illinois American Water for Six Months

Motion seconded by Trustee Metz

Mayor Pro Tem Wittenberg asks Administrator DuRocher to explain the ordinance

DuRocher stated that Illinois American Water is doing an excellent job. In the meantime we have hired a new water operator, Justin Fuller, and that he will be taking over the water system at some point in the future. One of their tasks will be working with the Village with the implementation of our system control and data acquisition system.

Motion carried by roll call vote (5-0). Trustees Mann, Farrell-Mayer, Metz, Wittenberg, and Conboy voted yes. No Nay votes. Trustee O'Laughlin absent.

7. Motion to award Geotechnical Services Contract

Trustee Conboy made a motion to award the bid for geotechnical services for the water main replacement program to Testing Services Corporation in the base amount of \$18,000.

Trustee Mann explained the purpose of the motion

8. Motion to Purchase Replacement HVAC System

Trustee Conboy made a motion to authorize the purchase/installation of a replacement HVAC system from Dahme Mechanical of Arlington Heights for a cost not to exceed \$34,3740

Motion seconded by Trustee Mann

Mayor Pro tem Wittenberg asked Administrator DuRocher to explain the motion.

Motion carried by roll call vote (5-0). Trustees Mann, Farrell-Mayer, Metz, Wittenberg, and Conboy voted yes. No Nay votes. Trustee O'Laughlin absent.

9. Motion to pass Ordinance 2018-21 Small Cell Antennas

Trustee Farrell-Mayer made a motion to pass Ordinance2018-21 an ordinance amending division 11, property maintenance code. Of chapter 6-346 of the Indian head park municipal code providing for the regulation of and application for small wireless facilities

Motion seconded Trustee Metz

Mayor Pro Tem Wittenberg asks Administrator DuRocher to explain the motion.

Administrator DuRocher stated that this is the model ordinance prepared by the Illinois Municipal League based on State law. The ordinance was reviewed by Attorney Brankin. He stated that it does offer the ability for plan preview and regulation of small cell towers.

Motion carried by roll call vote (5-0). Trustees Mann, Farrell-Mayer, Metz, Wittenberg, and Conboy voted yes. No Nay votes. Trustee O'Laughlin absent.

10. Chief of Police Cervenka presented statistic hours for police calls, hours worked by Village police officers for the month of April, traffic citations written by officers for the month, and training that was conducting for Village officers

He reported that he had started on the transition plan for 9-1-1 dispatching with the County.

He also reminded everyone to lock their vehicles.

11. Administrator DuRocher presented a draft ordinance regarding Airbnb regulation. He stated that short term rentals less than 30 days would be prohibited. Trustee Farrell-Mayer asked if there were any complaints to date. Administrator DuRocher

stated no. The general consensus was not to proceed further.

Trustee Mann reported that we are bidding out our road maintenance program. Ashbrook and Keokuk are our target areas. Thanks to Public Works for the repairs to Sacajawea Park

VILLAGE TREASURER: Absent

VILLAGE ATTORNEY: Absent

VILLAGE ADMINISTRATOR:

Reported that we hired a new public works employee, Justin Fuller.

Reported on stormwater management activities, including some problem areas in the Village. Three areas of concern, north end of Blackhawk. Run off from Hiawatha. Estimated cost \$33,000. Cochise (run off from Pontiac) estimated cost \$20,000 in total. The final area is Thunderbird/Cherokee, engineering is requested.

The Plaza's, 6493 Thunderbird Drive, stated that her neighbor to the east is pushing the storm water into their back yard. If the water could be piped to a new catch basin on Indian Head Trail would eliminate 70% of their problem. Administrator DuRocher stated that we could (the Village) could put in a catch basin on Indian Head Trail. The Plaza's stated that they would work with the neighbors to have this happen. Mr. Plaza stated that he would be willing to pay for the work in the neighbor's house.

Administrator DuRocher reported that the Village received notice that funding its grant application for the Invest in Cook grant was approved. The grant was for \$68,000. Our portion is \$20,000.
