**AN ORDINANCE AUTHORIZING THE SALE BY PUBLIC AUCTION
OF PERSONAL PROPERTY OWNED BY THE
VILLAGE OF INDIAN HEAD PARK, COOK COUNTY, ILLINOIS**

WHEREAS, Article 7, Section 10 of the Constitution of the State of Illinois encourages intergovernmental cooperation and authorizes units of local government to contract and associates among themselves to obtain or share services and to exercise, combine or transfer any power or function, in any manner not prohibited by law or ordinance; and

WHEREAS, the Intergovernmental Cooperation Act, 5 ILCS 220/1 et seq., and the Illinois Municipal Code 65 ILCS 5/1-1-5, et seq. and 5/11-15.1-1, et. seq., authorize units of local government to exercise their powers, privileges and authority for the purposes of intergovernmental cooperation; and

WHEREAS, the West Central Municipal Conference is a not-for-profit corporation comprised of municipal members dedicated to fostering intergovernmental cooperation; and

WHEREAS, units of local government have joined together in cooperation with the West Central Municipal Conference for the purpose of auctioning or otherwise disposing of surplus vehicles, equipment, and materials; and

NOW, THEREFORE, the aforesaid is hereby incorporated by reference and it is ordained by the Village of Indian Head Park Board as follows:

Section 1.

Pursuant to 65 ILCS, 5/11-76-4 or 65 ILCS 5/11-76-4.2, the following personal property is hereby declared to be surplus and not needed and it is hereby found that it would be best served by the sale of the below described personal property.

Section 2. MANNER OF DISPOSAL

The Village Administrator Is hereby authorized and directed to enter into an agreement with the West Central Municipal Conference for the sale of said surplus equipment described in Section 1 above. The sales shall be advertised and the auction conducted by an auctioneer compensated in the manner prescribed by the Conference. Participation is on a first come, first served basis. The auction has been scheduled for Saturday, June 29, 2013 at Triton College in River Grove, Illinois.

The WCMC has entered into an agreement with Obenauf Auction Service to conduct its Spring 2013 auction. Obenauf Auction Service Inc., shall accept the highest bid on each surplus item auctioned, provided same is no less than the minimum value individually set forth in Section 1 (unless a lower bid is approved by an authorized on-site Village representative. Upon verifiable payment of the auction price, the Village Administrator is hereby authorized and directed to convey and transfer title of the aforementioned personal property to the successful bidder.

Section 3.

The Village Administrator is hereby authorized to direct the sale of the aforesaid personal property at the next scheduled West Central Municipal Conference Auction.

Section 4.

This ordinance shall be in full force and effect from its passage.
